

## Entry Requirements for the Competition

- 1、 Entries should revolve around the theme of solar thermal power generation, showcasing the appearance of solar thermal power stations, technical equipment, operation and maintenance scenarios, and environmental benefits.
- 2、 Entries must be original and not previously published, exhibited, or awarded in any media. The content should be truthful and not violate any laws and regulations. Entries must not contain any advertising, have no intellectual property disputes, and plagiarism or copying is strictly prohibited. Participants shall bear full responsibility for any false content and misleading information in accordance with the law and regulations.
- 3、 Individuals and units submitting entries must ensure they are the authors of the works and hold independent, complete, clear, and undisputed copyright over the entire work and its parts. They must also ensure that their submissions do not infringe upon the legal rights of third parties, including copyright, portrait rights, reputation rights, privacy rights, or trade secrets. If music is used in short videos, it must be original or legally licensed. Any legal responsibilities arising from breaches of the aforementioned guarantees shall be borne by the submitter; if the organizer suffers damage as a result, it has the right to pursue legal responsibility from the individual or unit that submitted the entry.
- 4、 Works and behaviors that violate common standards and basic norms of various photography categories and are sufficient to harm public order and good customs will be immediately disqualified upon discovery. "Works and behaviors that harm public order and good customs" include, but are not limited to, those that may seriously mislead public cognition, are fraudulent in nature, or violate laws, morals, public order, or good customs. If there are disputes or controversies over intellectual property rights, reputation rights, privacy rights, or portrait rights, the legal responsibilities shall be borne by the individuals and units who submitted the entries and are unrelated to the organizer.
- 5、 The format of the entries includes both photographs and short videos. Photographs must be in JPEG format with a resolution of at least 300 dpi, and the size of each work should not exceed 10 MB. Short videos should not exceed 5 seconds in length, with a file size not exceeding 20 MB. They may be accompanied by music and should be playable on mobile devices. Photographic works must not bear any watermarks, logos, or be a collage of multiple images, and no modifications to the content should be made through graphic software or similar means. Short videos must not contain any corner marks or watermarks, and should avoid having black borders around the frame. If the video includes synchronous audio, the text of the audio must be provided.
- 6、 Each participant is limited to submitting 1 work, which must be accompanied by a brief description (including the shooting location, time, equipment, and creative concept, etc.); the work title should not exceed 8 characters, as a good work title can enhance its appeal.
- 7、 The subject of the photography must be solar thermal power stations within China, including those in operation and under construction. For shooting inside solar thermal power stations, key matters, or issues involving trade secrets, consent must be obtained from the owner unit of the solar thermal power station.
